# **ACE Conference 2008**

## **EU Institutions Bring Strong Support to ACE Conference**

With just eight weeks to go before the holding of the ACE Conference "Designing for the Future; The Market and Quality of Life", on the 10<sup>th</sup> April 2008, the ACE is delighted to inform you that Siim Kallas, Vice-President of the European Commission will open the proceedings of the day and Janez Podobnik, Minister of Environment and Spatial Planning of Slovenia, President-in-office of the EU Council of Ministers responsible for the Environment ad the Territorial Agenda, will give the closing speech. Furthermore, the European Parliament is involved in the Conference, notably its Inter-Group Urban.Logement.

Siim Kallas is the Commissioner from Estonia and he is, as Commissioner responsible for Administration, in charge of the Buildings Policy of the Commission. Indeed, as readers of the *ACE Info* will be aware, the Commission published its new Buildings Policy in mid-2007 and it announced, at the time, that it is preparing a specific document on its future Architectural Policy to complement its Buildings Policy – a matter on which the ACE has offered its assistance.

Work on the themes for the Conference is ongoing with focussed preparation underway with many of the confirmed high-level speakers (see programme on the website mentioned below). In this work both the Organising Committee and the appointed moderator for the event, Jan Maarten de Vet (of Ecotec), are engaged in ensuring that the quality of the presentations and of the discourse on the themes of the day will be of a consistently high calibre so that the event will be a true milestone for the ACE. ## **Core Issues**

## Study on Conveyancing Services Published

The European Commission published, on the 29<sup>th</sup> January 2008, the study that it had commissioned in 2006 on the subject of the EU market for legal services associated with house and land sales (Conveyancing services). The study follows the extensive work that the Commission undertook some years ago on competition in professional services and which it has continued to pursue. The latest study, carried out by independent consultants ZERP at Bremen University, finds that consumers in deregulated systems have greater choice, are paying less for Conveyancing services and are suffering no measurable loss of quality.

The study is in two parts, the first of which looked at the legal regimes in force in 21 countries finding that most of the arguments put forward do not seem to justify restrictions of the sort that feature in highly regulated systems. The second part looks at economic aspects in that sector of activity and concludes that high levels of regulation generally go hand in hand with high prices whilst not resulting in higher levels of quality – one of the principal arguments put forward by those defending regulation. #### Commission Includes Sustainable Construction in Lead Markets Initiative

"Lead Markets" are high-growth potential markets for research and innovation-rich goods and services and is a concept that was introduced into EU terminology by the "Aho Report" (see *ACE Info 2/06*). Lead Market initiatives will focus on areas where public authorities can facilitate industry-led innovation by creating favourable legal and regulatory frameworks, setting standards, improving access to risk capital, providing support for research and acting as launch customers.

The six areas chosen by the Commission are e-Health, Protective Textiles, Sustainable Construction, Recycling, Bio-based Products and Renewable Energy. In launching the initiative on the 21<sup>st</sup> December 2007, the Commission has set out an action plan for each of the areas for the coming years and there is clear potential for any proposals that display innovative approaches to any one of the areas receiving support, thus being potentially relevant for architects who devise innovative approaches to Sustainable Construction.

# The Commission Launches Legislative Proposals to Engage Europe on the Road to a Low Carbon Economy

On the 23<sup>rd</sup> January last, the European Commission presented, after lengthy and sometimes acrimonious negotiations, a package of concrete measures that it hopes will be as binding as the objectives of the European Council of March 2007 on energy and climate. The package includes proposals for the revision of the Community emissions trading scheme (ETS), a directive on the promotion of the use of renewable energy and other measures to combat global warming. In each of the measures, which collectively aim to ensure that the EU achieves its 20-20-20 target by 2020, the targets for each Member State is expressed as a function of its GDP per inhabitant, thus recognising the very different starting points for each Member State.

## Vicente Leoz-Arguelles Returns as Head of Construction Unit in DG Enterprise

Following the recent re-shuffle within DG Enterprise in which Mr. Reinhard Klein was appointed Head of the Entrepreneurship Unit at DG Enterprise, Mr. Vicente Leoz-Arguelles has resumed his post as Head of the Construction Unit, a post he held until 2006 when he was appointed to steer the revision of the Construction Products Directive. In that context, the ACE was invited to a stakeholder consultation on the subject in December 2007 at which it learned that the Commission is proposing to replace the Directive by a Regulation that simplifies many of the complicated provisions of the Directive. The proposed Regulation is currently in Inter-Service consultations in the Commission and will have to be adopted by the Parliament and Council after the Commission adopts it.

## Commission Preparing to Launch a Study on Liability and Insurance Regimes

The Construction Unit of the DG Enterprise is currently preparing a Call for Tenders for the carrying out of a European study of liability and insurance regimes in the construction sector. The ACE was invited to a stakeholder consultation on the matter at which it expressed its views on the subject and on its hopes for the outcome of the study. The ACE highlighted, among other things, the need to ensure that insurance policies truly protect the consumer interest, that all actors in the project team carry insurance appropriate to their input and that the law of the country in which the asset is constructed is the one that applies in case of dispute.

The Commission reported that the Study will survey the existing regimes in the Member States and that it will give an accurate overview of the situation in the EU. It also recalled that the Study is being undertaken in the context of earlier work in the 1990's on the Competitiveness of the Construction Sector and in the context of the requirements of the Directive on Services in the Internal Market.

## President Sarkozy Commissions Two Nobel Prize Winners to Re-examine GDP

The ACE notes with interest the recent mission that President Sarkozy of France has given to two Nobel Prize winners (for economics) Amartya Sen and Joseph Stiglitz, to consider ways and means to get away from a highly quantitative approach to measuring wealth and collective performance to somehow include well-being and satisfaction or other indicators of real wealth. Readers will recall that in ACE Info 7/07 that we reported on steps being taken by the European Commission to work in this direction too. These developments give support to the calls that the ACE has now been making for many years that pure economic prosperity (expressed as GDP per capita, for example) is not sufficient as the only measure of quality of life. It has highlighted the need to ensure that more indicators, particularly those that can "measure" the quality of the built environment need to be devised and integrated into national statistics. The ACE will track these interesting developments and report back on any significant progress that either initiative makes.

# **European Commission to Examine New Planning Law in Belgian Commune**

On the 20<sup>th</sup> December last, the European Commission announced its intention to analyse the legal provisions of a regulation that will allow the commune of Zaventem (located just outside Brussels in Flanders) to exclusively reserve the acquisition of building land to persons who speak Flemish or who are taking Flemish lessons in a recognised school. No further details are available at the present time.

# **EUA Requested by French Presidency to Develop Lifelong Learning Charter**

In setting out the higher education priorities of the future French Presidency of the EU, the French Prime Minister, François Fillon, invited the Presidents of the 34 National rectors Conferences of the European University Association (EUA) to debate how universities could contribute to the development of European society and the labour market. In response the EUA President, Georg Winckler, promised that he would strive to ensure that the EUA would develop a Charter that is supported by all its member universities. understanding between different cultures. According to a recent Eurobarometer public opinion survey, two thirds of Europeans interact with at least one person of a different religious, ethnic or national background every day, a fact that underlines the fact that intercultural dialogue is a common daily feature of life in the EU.

This focus on culture comes at a time when the European Parliament has called for a sharper focus on the jobs and growth potential of cultural industries. # Eurochambres Survey of State of Play in Transposition of Services Directive

The Association of European Chambers of Commerce and Industry (Eurochambres) has published the results of a survey carried out among 26 national Chambers of Commerce on the progress made and delays accumulated by Member States in the transposition of the Services Directive (2006/123/EC). Although 85% of Member States have launched national plans for transposing the directive, the survey shows that significant national differences concerning specific provisions exist. In particular it notes that there is still a lack of clarity when it comes to the model of organisation for the *one-stop shops*. Some Member Sates have chosen to give exhaustive competences to their proposed *Points of Single Contact (PSC)*, while others have only given them the role of facilitator. In some countries the national Chambers of Commerce are looking at the possibility of acting as the PSC.

#### The "Covenant of Mayors" Launched

On the 29th January in Brussels, in the presence of elected representatives from London, Helsinki, Riga, Berlin, Bonn, Milan, Venice, Nantes, Ljubljana, Warsaw and other cities, the European Commissioner for Energy, Andris Piebalgs and the President of the Committee of the Regions, Michel Delebarre, officially launched the Covenant of Mayors. This initiative aims to involve citizens in the fight against global warming and was part of the second European Union Sustainable Energy Week. Almost 100 cities, including 15 capital cities have expressed their support for the Covenant. Mr. Piebalgs said that cities are becoming the places to deliver new ideas and innovative projects against global warming and he affirmed that the approach to tackle the climate crisis challenge can only be holistic, integrated, long-term and, most of all, based on the participation of citizens.
